### When do I have to lodge this form?

The managing owner must lodge this form:

• Within 7 days of a decision to retire a breeding horse,

### Why do I have to lodge this form?

It is required under AR 307 Decision to retire breeding horse to enable traceability of horses throughout their lives to ensure positive welfare outcomes.

### How will my personal information be used?

The personal information collected in this form may be used by Racing Australia and the Principal Racing Authorities to identify and communicate with owners and to facilitate the administration of racing. It may also be used or disclosed by Racing Australia in accordance with its Privacy Policy (<u>https://racingaustralia.horse/AboutUs/PrivacyPolicy.aspx</u>). The Privacy Policy also sets out how owners can access and seek correction of their personal information, as well as how to make complaints regarding Racing Australia's handling of their personal information.
