

Which horses does this form apply to?

- Unnamed horses (i.e. FOD lodged but not registered to race).
- Named horses (i.e. registered to race).

When do I have to lodge this form?

Within 7 days of your horse not having any activity recorded with Racing Australia/Principal Racing Authority in 6 consecutive months, the managing owner must lodge this form.

Racing Australia will send reminders to the managing owner and trainer (if applicable) before the 6-month mark.

Do any exemptions apply?

You do not have to lodge this form if the trainer of the horse (if applicable) completes the update.

How do I lodge this form once completed?

Why do I have to lodge this form?

It is required under AR 293 (unnamed horses) and AR 300 (named horses) to enable traceability of horses throughout their lives to ensure positive welfare outcomes.

How will my personal information be used?

The personal information collected in this form may be used by Racing Australia and the Principal Racing Authorities to identify and communicate with owners and to facilitate the administration of racing. It may also be used or disclosed by Racing Australia in accordance with its Privacy Policy (<u>https://www.racingaustralia.horse/AboutUs/PrivacyPolicy.aspx</u>). The Privacy Policy also sets out how owners can access and seek correction of their personal information, as well as how to make complaints regarding Racing Australia's handling of their personal information.
