

# Retired Horse Status Update

# Which horses does this form apply to?

- Unnamed horses in respect of which a decision has been made to not commence racing.
- · Named horses which have retired from racing.

### When do I have to lodge this form?

Within 7 days of any of the following occurring:

- Your horse is sold/transferred to another person (including an approved livestock sale).
- · Your horse changes location.
- · Your horse retires from its current career (e.g. equestrian).
- · Your horse dies.

#### Do any exemptions apply?

You do not have to lodge this form if your horse is away from its previously notified location:

- For up to 30 days because it is obtaining veterinary treatment; or
- For up to 7 days because it is attending an auction.

# Why do I have to lodge this form?

As an industry participant, it is required under AR 291 (unnamed horses) and AR 298 (named horses) to enable traceability of horses throughout their lives to ensure positive welfare outcomes.

#### How will my personal information be used?

The personal information collected in this form may be used by Racing Australia and the Principal Racing Authorities to identify and communicate with owners and to facilitate the administration of racing. It may also be used or disclosed by Racing Australia in accordance with its Privacy Policy (<a href="https://www.racingaustralia.horse/AboutUs/PrivacyPolicy.aspx">https://www.racingaustralia.horse/AboutUs/PrivacyPolicy.aspx</a>). The Privacy Policy also sets out how owners can access and seek correction of their personal information, as well as how to make complaints regarding Racing Australia's handling of their personal information.
